Memorandum of Understanding





THIS MEMORANDUM OF UNDERSTANDING is made this 16 September 2021

BETWEEN

TUNG WAH COLLEGE LIMITED (hereinafter referred to as "TWC")

and

THE ASSOCIATION OF HONG KONG CHINESE MIDDLE SCHOOLS (hereinafter referred to as "The Association")

This Memorandum of Understanding (hereinafter referred to as "MoU") is entered into by Tung Wah College Limited (hereinafter referred to as "the College") and The Association of Hong Kong Chinese Middle Schools (hereinafter referred to as "The Association") regarding the following Special Admission Scheme ("hereinafter referred to as "the Scheme").

1. Objectives

- 1.1 The MoU is to encourage the students who are studying in the member schools of The Association to apply for the programmes offered by the College through a Special Admission Scheme. The Scheme is comprised of the following two parts:
 - i. Waiver of Application Fee
 - ii. Principal's Recommendation Scheme

2. Period of Agreement

- 2.1 This MoU will be effective from the date of signing and will remain in force until completion of the Admission Exercise for the 2022/2023 2026/2027 intake.
- 2.2 Any amendments and / or modifications to this MoU will require written consent from the Heads of both parties or their authorized representatives.
- 2.3 After completion of the Admission Exercise for the 2022/2023 2026/2027 intake, this MoU may be renewed upon written agreement of both parties.
- 2.4 Either party reserves the right to terminate this MoU upon one month's notice to the other party inwriting.

3. Scope of the Scheme

3.1 Eligibility of Applicants

An applicant would be considered eligible for the Scheme if he/she is a:

- i. Form 6 student studying in one of the member schools of The Association; and
- ii. Current candidate of the Hong Kong Diploma of Secondary Education Examination (HKDSE)

3.2 Waiver of Application Fee

A waiver of 100% of the application fee would be granted to an eligible applicant who submits an application.

3.3 Principal's Recommendation Scheme

i. School principals of The Association may recommend their students for admission to any **ONE** of the below listed programmes offered by the College:

<u>List of TWC programmes accepting recommendations from the Principals of The Association:</u>

- Bachelor of Education (Honours) in Early Childhood Education*
- Bachelor of Management (Honours) in Social and Business Sustainability
- Bachelor of Medical Science (Honours) Major in Basic Medical Sciences / Forensic Science
- Bachelor of Science (Honours) in Applied Gerontology
- Bachelor of Social Science (Honours) in Applied Psychology
- Higher Diploma in Early Childhood Education*
- Higher Diploma in Health Science
- Higher Diploma in Nursing*
- Higher Diploma in Psychology

(* Programmes requiring professional registration)

- ii. Interviews will not be required **EXCEPT** for the three programmes which require professional registration (i.e., programmes marked with * in the above list). **TWO marks** will be added to the interview score of each recommended student.
- iii. The College will make **ONE conditional offer** to each recommended student as deemed appropriate.
- iv. HKDSE score requirement for the **Higher Diploma in Nursing programme** will be kept at **14** for the 2022/2023 intake: and
- v. Each Principal of The Association is allowed to submit a **maximum of THREE recommendations** to the College among which only **ONE** would be for a programme that requires professional registration."

4. Responsibilities

- 4.1 The Association, on behalf of its member schools, takes on the responsibility to communicate, discuss and negotiate with the College. In addition, The Association will distribute and promote this Scheme to its member schools.
- 4.2 The College will be responsible for providing updated admission information to The Association and implementing the Scheme as specified above.
- 4.3 This MoU shall commence on the date of signing and be in effect for the Admission Exercise for the 2022/2023 2026/2027 intake. Either party may terminate this MoU by written notification signed by the Head or the authorized representative of the concerned party.
